#### **USER AGREEMENT**

#### PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY.

SupportMyClub.org ("SMC") require that all visitors ("you") to its site, SupportMyClub.org, and its other sites (collectively, the "Sites"), agree to all of the terms and conditions in this User Agreement ("UA"). By accessing and using the Sites, you indicate your acknowledgment and acceptance of this UA. As used in this Agreement, "we," "our," and "us" means SMC unless otherwise indicated.

# Who is SupportMyClub.org?

SMC is a 501(c)(3) not-for-profit corporation. We at SMC aim to improve public education by engaging citizens in fulfilling the needs of high school clubs and teams. The Sites provide you with access to an online collection of information, materials and services related to SMC and its work, including text, pictures, photographs, audio and video, graphics, logos, marks and images (collectively, "Content"), as well as software used in accessing the Sites, displaying the Content, and utilizing the functionality offered through the Sites ("Software"), all of which are subject to this UA. Unless stated otherwise, any new Content and Software added to the Sites and all revisions, modifications, and enhancements to the Sites, the Content or the Software will be covered by this UA effective upon the date of each such addition.

# Eligibility.

Use of the Sites is void where prohibited. By using the Sites, you represent and warrant that (1) all information you submit is truthful and accurate; (2) you are 18 years of age or older or have received parental consent and supervision when using the Sites; and (3) your use of the Sites does not violate any applicable law or regulation. Your use of the Sites may be terminated without warning if we believe you are in violation of any of these conditions.

## Binding Agreement.

By using any Site, you agree to be bound by this UA, whether you are a visitor, Club or Donor. The use of the Sites (including, without limitation, photographs or images), by you, or anyone else authorized by you, is prohibited except as allowed by this UA. Thank you for your interest in funding a student request at SupportMyClub.org. By clicking the "I Agree" button during the sign-up process for donations, the following additional terms of the UA apply to those users who sign up for a donor account and/or donate to a request on the Sites ("Donor").

## Donor Representations

By applying to become a Donor, you promise that:

- 1. You are a U.S. citizen at least 18 years old or if under 18 years old are acting with parental consent and under parental supervision;
- 2. All information you provide to SMC is accurate, and you will update the information to keep it accurate; and
- 3. Any donation you make is legal in your jurisdiction.

# Donor Responsibilities

You will be responsible for the use and maintenance of the confidentiality of your user ID and password (which you will receive upon completing the process of registering as a Donor) for access to Donor-restricted portions of the Sites, and shall not share your ID and password with anyone else. You agree not to use the account, username, or password of another Donor or Club at any time or to disclose your password to anyone else. You agree to exit from your account at the end of each session and to immediately notify SMC of any unauthorized use of your password or account. Recognizing the critical importance of these restrictions in protecting the rights and privacy of the participants, you agree that any breach by you of any of these restrictions may cause SMC and others to suffer irreparable loss, damage and harm in an amount not easily ascertained, and therefore agree that SMC may immediately seek an injunction against you to stop your distribution, display, or copying of any such materials and you waive any objection to the scope or venue of such an action.

# Services Provided by SMC

We verify that each Club is in fact an officially recognized club at its school (e.g. by reviewing completed constitutions and/or bylaws, verifying school official approval, etc). We review, verify and calculate the cost of each Club request before we post it on the Sites for Donors to view. Our efforts include, but are not limited to, screening the proposed student requests for compliance with the SupportMyCLub.org eligibility requirements, restricting Clubs to addresses that have been provided by the school system as correct school locations, confirming the existence of

requested materials, and determining a cost for the request. Whenever practical, we purchase the necessary materials ourselves and arrange for them to be delivered directly to the Club's school. For all donations, we arrange to the best of our ability for a Club letter, photographs of students engaged in the activity and student thank-you notes to be sent to the Donor(s) after student receipt of the item(s).

We take reasonable steps to protect the privacy of any personal and financial information you may provide to us when you donate through the Site as described in our Privacy Policy.

SMC reserves the right to exclude any Donor from use of the Sites, in SMC's sole discretion. All directions and requirements stated on the Sites regarding Donors or donations shall apply to any donation offered or made by you.

#### **Disclaimers**

If, for any other reason, the request cannot move forward (i.e., the Club no longer operates at the specified school or no longer requires the requested materials, or the Club is no longer in good standing with SMC, etc.), all donations made to the request will be reallocated to our general item matching fund and used to procure other student needs.

SMC cannot be responsible for the success of any proposed or funded requests or for the activities (or lack thereof) of the Clubs or students participating in any proposed or funded requests.

## Special Provisions for Clubs

Thank you for your interest in submitting a request for a SupportMyClub.org item. By clicking the "I Agree" button during the process to sign up for funding requests, the following additional terms of the UA apply to those users who sign up for a Club account and/or to post a Club funding request on the Sites ("Clubs"):

## Club Representations

By submitting a request, you promise that:

- 1. You are a teacher, librarian, guidance counselor, coach or other public school employee directly serving students (review our Club eligibility guidelines) and a current employee or registered volunteer at the school you note;
- 2. The item you propose is legal and falls within the standards of your board of education; all information you provide to SMC is accurate, and you will promptly update the information to keep it accurate;
- 3. Any requests you submit are solely for you and your Club and are not on behalf of any other

## Club or class; and

4. You have full rights to any ideas, descriptions and materials you submit to SMC, and that you (and not SMC) are solely responsible for such submission, including its legality and appropriateness, and that all such materials are your original creations and use by SMC will not infringe on any rights of any third party.

# Club Responsibilities

You will be responsible for the use and maintenance of the confidentiality of your user ID and password for access to Club-restricted portions of the Sites, and shall not share your ID and password with anyone else. You agree not to use the account, username, or password of another Member at any time or to disclose your password to anyone else. You agree to only have one account; please note that multiple accounts are prohibited. You agree to exit from your account at the end of each session and to immediately notify SMC of any unauthorized use of your password or account. From time to time, SMC or a third party on SMC's behalf may send you emails regarding important information regarding your use of the Sites. Even if the electronic communication system that sends such emails to your account contains an "opt-out" feature, you acknowledge and agree that it is your responsibility to be aware of the information contained in these emails.

# Rights You Grant to SMC

You agree that requested resources will be used by students or to provide a student experience as described in your request. You will use SMC's funds and materials only for the request SMC has approved, and agree to follow all other instructions as provided or directed by SMC regarding the funded activity. You understand that the promptness and thoroughness with which you return the photographs and thank-you notes may effect how many requests you are allowed to submit in the future.

#### **Disclaimers**

SMC will not be required to treat any Submission or Request as confidential.

#### **Termination**

You may terminate this UA by destroying all materials obtained from the Sites, cancelling your Donor or Club account, as applicable, and stopping all use of the Sites. SMC may terminate this UA immediately at will for any reason, in its sole judgment, without warning or prior notice. Upon termination, you must destroy all materials obtained from the Sites and stop all use of the Sites.

#### Miscellaneous

This UA is governed by the laws of the State of Arizona, USA and controlling United States federal law without regard to its choice of law or conflicts of law provisions. You agree that any action to resolve or enforce any dispute or arbitration award regarding use of the Sites or this UA will be brought exclusively in the federal or State courts located in Phoenix, Arizona. If any provision is deemed by a court of competent jurisdiction to be unlawful or unenforceable, it will not affect the validity and enforceability of the remaining provisions. The section headings are for convenience only and do not have any force or effect.

# Resolution of Disputes

THIS UA CONTAINS A BINDING ARBITRATION PROVISION WHICH MAY BE ENFORCED BY THE PARTIES.

Any controversy or claim arising out of or relating use of any Site shall be settled by binding

arbitration in accordance with the commercial arbitration rules of the American Arbitration Association to be heard and adjudicated by one arbitrator to be mutually chosen by you and SMC. Any such controversy or claim shall be arbitrated on an individual basis, and shall not be consolidated in any arbitration with any claim or controversy of any other party. The arbitration shall be conducted in Phoenix, Arizona, and claims regarding the judgment of the arbitrator (including entry of judgment on the arbitration award) may be brought and shall be subject to the exclusive jurisdiction of the State and federal courts located in Phoenix, Arizona, and you waive any jurisdictional, venue, or inconvenient forum objections to such courts. Either you or SMC may seek any interim or preliminary relief from a state or federal court of competent jurisdiction in Phoenix, Arizona, as may be necessary to protect the rights or property of you or SMC pending the completion of arbitration.

#### Indemnification

You agree to indemnify and hold SMC and its Affiliates harmless from and against any and all loss, liability, claims, causes, actions, damages or penalties, including reasonable attorneys' fees, made by any third party due to or arising out of: (1) your use of any Site in breach or violation of any term of this UA; (2) your violation of any law or regulation; (3) breach of your representations and warranties as set forth herein; or (4) any content you provide to SMC.

# Entire Agreement

This UA, including the terms specifically applicable to Donors and Clubs, and other policies and notices SMC may post on the Sites necessary for access to Donor and Club portions of the Sites, constitute the entire agreement between SMC and you in connection with your use of the Sites, hyperlinks to the Sites and the Content and Software displayed on the Sites, and supersedes any prior agreements between SMC and you regarding such matters, including prior versions of this UA. SMC may update this UA from time to time by posting revised versions of this UA on the Sites, without notice to you except that the effective date at the top of this UA will change and your subsequent use of the Site is governed by that new UA. The terms of this UA are effective until terminated by SMC, at any time without notice. In the event of termination, the disclaimers, limitations of liabilities and indemnities set forth in this UA will survive.
